Van Horn Law Group, P.A. was recently named the fourth largest bankruptcy firm in Florida based on the number of Chapter 7 cases filed in 2019 out of 1,367 filers by 722 Redemption Funding, Inc., a firm that assists Chapter 7 debtors in cost-effectively keeping or replacing their car during the bankruptcy process. The Redemption Funding survey also ranked Van Horn Law Group as the 22nd largest bankruptcy firm in the United States based on Chapter 7 filings out of 20,160 filers.

Van Horn noted that the firm’s success rate of Chapter 7 filings is 98 percent, and its success of Chapter 11 filings is 60 percent, nearly twice that of the nation average of 33 percent.

As the largest bankruptcy firm in Broward County based on total cases filed according to Pacer.gov, Van Horn Law Group ranked among Inc. magazine’s 5000 fastest-growing companies in 2019. With growth of 61 percent and revenues of \$2.5 million, the 25-member firm landed in position number 4,695 on Inc.’s list, ranked 146 across all business categories, and came in at 11 in the Consumer Products and Services category.
